### NOTICE

KIEP 250+ is designed to help strengthen the productivity and internal capacity to innovate for 250 carefully selected SMEs. We do so by improving managerial and technical skills, and the SMEs use of technology. Our goal is to significantly increase business resilience, productivity, competitiveness and enhance market linkages.

Each Call for Application under KIEP 250+ aims to include at least 50 qualifying SMEs. The actual number of short-listed SMEs may be lower or higher than the target of 50, dependent on applicants meeting the eligibility criteria and the outcome of the evaluation processes.

SMEs who meet the eligibility criteria are encouraged to apply online through https://250plus.kiep. go.ke. The KIEP 250+ application platform allows for a fully transparent and efficient process that reduces the time taken by applying SMEs to complete the application procedure.

This guideline is meant for SMEs who are interested to understand the KIEP 250+ eligibility criteria and wish to understand the application procedure.

#### BACKGROUND

The Government of Kenya (GoK) is implementing the Kenya Industry and Entrepreneurship Project (KIEP) in partnership with World Bank for a six-year period from 2018 to 2024. KIEP is being implemented by the Ministry of Investments, Trade and Industry – State Department for Industry.

The Project Development Objective is to increase innovation and productivity in select private sector firms, in line with Kenya's Vision 2030 and Medium Term Plans that have set ambitious growth targets in private sector employment generation, export expansion, and increasing competitiveness and productivity.

KIEP will provide Technical Assistance through financial grants and its direct beneficiaries are fast growing SMEs that operate in key economic sectors in Kenya.

#### **KIEP consists of three components:**

- 1. Strengthening the innovation and entrepreneurship ecosystem;
- 2. SME Linkages and Upgrading; and
- 3. Project implementation support and M&E

This SME application guide deals with Component 2: **SME Linkages and Upgrading**.

The aim of this part of KIEP is to increase productivity and innovation within established Kenyan SMEs by supporting select firms to improve their managerial and technical skills and their access to and use of technology, in order to significantly increase operational competitiveness.

KIEP 250+ will work with at least 250 fast-growing SMEs and assist them to drive innovation and improving value addition. Shortlisted SMEs accepted into the project will receive an integrated package of diagnostic and advisory services and financial support for the implementation of identified gaps that need to be addressed in order to increase innovation, productivity and competitiveness.

KIEP 250+ is managed by a consortium of international development consulting fi rms led by NIRAS Finland Oy ("the Fund Manager"), with Intellecap Advisory Services Private Limited Kenya as sub-contractor and supporting partner.

The major part of the implementation will be carried out by NIRAS Africa Ltd of Kenya, which is part of the NIRAS Group. NIRAS Finland Oy and NIRAS Africa Oy will be referred to jointly as NIRAS.





## **ELIGIBILITY CRITERIA**

The selection of beneficiary SMEs is based on objective criteria as described below:

#### **Eligible SMEs are firms:**

- Who have been nominated by lead firms or other third parties such as financial institutions or industry associations;
- Whose annual turnover falls between KES 50m-1b. This turnover may be from the previous financial year, or an average annual turnover from the previous three years;<sup>1</sup>
- Active in the BETA sectors with a special focus on value-adding industries;
- Who may have export potential;
- Whose management is committed to participating in the program
- Who are incorporated in Kenya and have been in existence for at least two years, and are not insolvent;
- · Who are able to present audited financial statements.

#### Who can nominate an SME?

To become eligible for inclusion into KIEP 250+, an SME must be nominated by a Strategic Partner which includes Lead Firms, Financial Institutions, Business Associations or other stakeholders.

#### Lead firms are those who:

- Belong to sectors of the economy with potential to use local suppliers and with potential to export goods and services, or;
- Are a major buyer of goods and/or services from Kenyan suppliers that are SMEs;
- Have part or all of their supply chain in Kenya, or;
- Have suppliers that are SMEs that add value in Kenya, or;
- Want to build their local supply chain in Kenya.

**Financial Institutions** include commercial banks, non-bank finance institutions (NBFIs), Investment/Private Equity Funds or other financial institutions that work with SMEs.

**Business- and Industry Associations** are membership organizations, often organized per sector or profession, who would nominate member-SMEs


**Other Strategic Partners** include women organizations, NGOs and/or other professional firms who work with SMEs.

**Own Contribution** by the SME is a minimum of 30% of the project's total costs, in monetary and/or non-monetary contributions. This contribution need not be upfront and can be spread across the duration of the performance contract.

<sup>1</sup>KIEP 250+ retains the right to accept smaller SMEs on a case-by-case basis.



### **PROCESS** OVERVIEW



STEP 1	The KIEP 250+ project team reaches out to Strategic Partners to alert them that a new Call for Application will shortly be launched and discuss with them the prospect of nominating eligible SMEs;
STEP 2	The Call for Application officially opens on SMART ME platform. The Call will remain open for 3 weeks;
STEP 3	Shortlisted SMEs will receive an official communication informing them of next steps;
STEP 4	Comprehensive due diligence to verify the information provided by SMEs is undertaken;
STEP 5	A diagnosis of the shortlisted SME, its commercial objectives, organization and opera- tional processes is undertaken and key priority areas for improvement are highlighted;
STEP 6	A Performance Improvement Plan (PIP) is developed jointly by the shortlisted SME and a KIEP 250+ appointed Business Advisor. The PIP will state the agreed areas of Technical Assistance;
STEP 7	Specialist Business Development Service providers who are qualified to execute the agreed Technical Assistance projects are shortlisted and contracted;
STEPS 8-9	KIEP 250+ provides 12 months of technical assistance to help achieve the business improvement objectives highlighted in the Performance Improvement Plan (PIP);
STEP 10	The SME reports on agreed key indicators enabling us to measure the success and impact of the Technical Assistance grant.



#### Before filling in the application form for any of the calls:

- Kindly note that you can save your application and resume where you left off.
- The application form automatically logs out after 120 minutes. This protects your privacy.
- SmartME saves data entered frequently and automatically. You do not have to fill in the information in one go. Click on "save as draft" before logging-out.
- On the left of the application form is a countdown timer. It tells how much time you have left to apply before the application closes automatically. It is highly recommended not to wait until the last moment to submit the application.






